

## What We Do

We assist you in fulfilling your desire to give to the Catholic causes that reflect your personal faith and values.

As a donor, you may elect to provide unrestricted or restricted funds, or both. You may assign your gift to your own parish for its use in any manner you specify. You may also designate your donation to a specific program or organization in the Diocese, or simply designate it to be used to provide the greatest good to the greatest number. The Foundation will work with you to clearly define your wishes and to establish a program that will utilize your gift exactly as you desire. We help you leave a lasting legacy of your faith to the parishes, schools and organizations that have been most meaningful in your life. Establishing an endowment is that simple. There are a number of ways you can establish an endowment through The Foundation.

## How We Do It

We provide options to fit your giving objectives. We will be able to provide important information about the planning options available to you. We have materials that should answer your questions and we can direct you to other resources that can help you make the most appropriate decision.

**Wills and Bequests** – the most popular tool names a specified amount or percentage from your estate to permanently benefit your favorite program of the Diocese.

**Gift Annuities** – you receive an annual lifetime income in exchange for a cash gift or securities. This tool may reduce capital gains taxes and even provide tax-free return of the principal.

**Life Insurance** – you direct the proceeds, cash value of policy or any portion of it, to benefit any diocesan program or institution for either restricted or unrestricted purposes.

**Real Estate** - with investments down and real estate values rising, an opportunity to use your home, raw land or even a vacation property that has appreciated in value can be given without incurring tax on the appreciation.

**Charitable Remainder Trust** – you fund the trust and then direct its proceeds or a fixed percentage to support various efforts through The Foundation. This tool may reduce both capital gains and income taxes.

**Endowment Fund** – you provide a perpetual source of revenue for the Diocese, your parish, school or other Catholic organizations or ministries that are meaningful to you. The principal of your gift remains and continues to grow.
